Subcontractor hereby approves any change order document issued by Contractor covering work for which payment is sought in whole or in part by this Requisition, even if Subcontractor has not yet executed the change order document.</li> <li>6. The person signing below has authority from Subcontractor and has personal knowledge that this Requisition and all statements herein are true and correct.</li> </ol> <p>For valuable consideration, Subcontractor hereby waives and releases any and all claims and/or lien rights which Subcontractor may now have relating to the Subcontract, through the payment period covered by this Requisition.
